- A copy of yoga teacher training course schedule / timetable.
- A copy of “Code of Ethics” for the yoga teacher training courses. (Registered yoga schools must include their Code of Ethics in their curriculum and set a good example for their students)
- A copy of student enrolment form, which must clearly indicate the prerequisites of enrolment, educational qualifications and yoga experience of the student.
